#### **CHAPTER I**

### **INTRODUCTION**

#### A. Background of the Study

Indonesia is one of the potential destinations as the venue of Meetings, Incentives, Conferences, and Exhibitions (MICE), one of them is Bali which is still the main prima donna for doing Meetings, Incentives, Conferences, and Exhibitions (MICE) activities. This is evidenced by the large activities at both national and international levels held in Indonesia. The G20 (Government Twenty) events prove the world community's trust to carry out Meetings, Incentives, Conferences, and Exhibitions (MICE) activities. Based on the data collected by International Congress and Convention Association (ICCA) in 2019, Indonesia ranks 10<sup>th</sup> in Asia Pacific as a destination for holding the most meetings.

Meetings, Incentives, Conferences, and Exhibitions (MICE) are a part of the tourism industry, which is rapidly developing. According to Pendit in Rai Utama (2017), MICE is defined as convention tourism, with limitations in the form of convention services, incentive trips, and exhibitions, which is a business with activities providing services for a meeting of a group of people (statesmen, businessmen, scholars, etc.) to discuss issues related to the common interest. According to Kesrul in Rai Utama (2017), MICE is defined as the tourism activity whose activities are a combination of leisure and business, usually involving a group of people together, a series of activities in the form of meetings, incentives, travels, conventions, congresses, conferences, and exhibitions.

The meeting is an English acronym that means meeting, assembly, or trial. In Meetings, Incentives, Conferences, and Exhibitions (MICE), a meeting is defined as an activity of a group of people who have a certain theme or topic that aims to achieve the purpose of the specified theme or topic. An incentive is defined as a bonus or incentive that is given by the company to the employees. A convention or conference is defined as a meeting activity in a broad scope involving many countries and people to negotiate or exchange opinions regarding a common problem. An exhibition is an activity held to disseminate information and promotions related to tourism activities.

Organizing Meetings, Incentives, Conferences, and Exhibitions (MICE) certainly consist of various components that next can determine the success of the event being held. That starts with bidding preparations carried out by the Professional Conference Organizer (PCO), Event Management Company, or Event Organizer (EO) to become the event organizers. Then it will be continued with other matters such as handling accommodations, transportation, transfer-in and transfer-out, airport service, correspondence and license, registration, food and beverages, consumption, health and security, function, impresario, liaison officer, spouse program, multimedia and IT, procurement, design graphic, finance and administration, publication and documentation, and human resources.

PT Bintang Nusantara MICE is one of the best Event Management Companies in Bali which is usually handled meetings, incentives, conferences, and exhibitions (MICE). The International Training on Toponymy is the last event handled by PT Bintang Nusantara MICE at the end of June 2023. The event is coorganized by the Indonesian Geospatial Information Agency (*Badan Informasi Geospasial - BIG*), the United Nations Group of Experts on Geographical Names (UNGEGN) Secretariat, and the United Nations Group of Experts on Geographical Names (UNGEGN) Working Group on Training Courses in Toponymy. International Training on Toponymy is a training naming procedure, especially the standardization related to naming the appearance of the earth. The event theme is "Geographical Names of Heritage" which are present five materials, including National Agencies, Models, and Procedures, Cultural Heritage in Bali, and Geographical Names Collection Systems.

The International Training on Toponymy was attended by participants from Indonesia, Malaysia, Brunei Darussalam, Arab Saudi, Laos, Oman, Jordan, and Vietnam. The meeting was held at Padma Resort Legian from 19<sup>th</sup> May 2023 to 23<sup>rd</sup> May 202. The preparations to handle this event consist of several processes such as coordinating with the initiator or committee of the event, coordinating with the event venue, coordinating the meeting package and room rental, convention logistics equipment, multimedia, registration website, printing, documentations, publications, office stationery for the event needs, souvenir, seminar kit, consumption, transportation, core personnel, and support personnel. In this case, one of the important things that must be prepared is the registration. Registration is the heart of meetings and events because registration is the first step for the participants to attend the meetings or events. The event registration will secure participants and thus how secure potential revenue. In addition, registration acts as the first impression the participants will have about the event or meetings and may impact their event satisfaction. As a result, we need to ensure the event registration process is as efficient and user-friendly as possible.

Based on the background of the study above, the author is interested in doing a final project in discussing the registration section entitle "Handling Event Registration Procedure of the International Training on Toponymy by PT Bintang Nusantara MICE".

The data collection method used is as follows:

#### a. Interview Method

In this case, the author did direct observation at PT Bintang Nusantara MICE and the venue of the event took place so that through that observation the author got a piece of incredible information.

c. Literature Method

The literature method is a data collection technique that the author did by combining theories and understandings contained in written sources (reference books) related to the final project. Data collection was done by collecting and studying documents or data that support the theme of the final project. 2. Methods and Techniques of Data Analysis

#### **CHAPTER V**

#### CONCLUSION

#### A. Conclusions

Based on the description of the discussion in Chapter IV, regarding the handling event registration procedure of the International Training on Toponymy by PT Bintang Nusantara MICE has three conclusions as follows:

- Handling Event Registration Procedure of the International Training on Toponymy has three stages including:
  - a. Stage Before the Day of the Event (Pre-Event), at this stage the registration team of PT Bintang Nusantara MICE held a coordination meeting with the initiator or committee regarding the registration needs. The registration team also set up equipment related to creating a registration website including information about the schedule of events, information of trainers, accommodations, and side programs, and also installing the system including maintenance for three months (online registration), and preparing the needs of the printing ID cards with lanyards.
    - b. Stage on the Day of the Event (Onsite Event), at this stage the registration team ensures that all tools and equipment related to registration during the activity are ready for use, distributed all equipment and tool related to the registration needs to the venue, and did a trial run before use handled the registration procedure at the venue of the event.

- c. Stage After the Day of the Event (Post-Event), at this stage the registration team of PT Bintang Nusantara MICE collected the participants' data including the result of the participants' registration from day one to day five including participants' data, tap in and tap out of participants' data, as well as signed manual absence data.
- 2. In the preparation and implementation of handling event registration procedure of the International Training on Toponymy, there were several obstacles such as new participants on the day of the event which must be printed out at that time, some participants' ID Cards cannot be scanned because of missing to registered on the back-office system, and the weak of speed internet connection.

#### B. Suggestions

Based on the obstacle phase during the handling event registration procedure of the International Training on Toponymy by PT Bintang Nusantara MICE can put forward some suggestions as follows:

1. During the stage the day before the event (pre-event) the registration team of

PT Bintang Nusantara MICE should make sure about the participants' data who will be joining the event with coordination to the initiator of the event, especially about the Id card that needs to be printed.

2. The Registration team of PT Bintang Nusantara MICE must double-check the attendee's ID cards, especially about the participants' chips in their ID cards are had been registered in the back office or not registered yet, because it is

important to anticipate if their participants cannot enter the meeting room because their ID card cannot be scanned.

 The registration team must always coordinate with another team, especially the IT team related to laptop and internet needs.
